#### Minutes – SRM IMS Section Meeting – Big Valley, Alberta – July 22, 2006

The International Mountain Section of the Society for Range Management held its summer meeting in Big Valley, Alberta, Canada on July 21, 2006. Section President, Maynard Smith, called the meeting to order at about 9:00 AM.

Maynard introduced the officers and board members who were present.

It was moved and seconded that the meeting notes from the fall 2005 meeting be approved as they appeared in the Section's Newsletter. The motion carried.

Thanks to Angela Burkinshaw and all those who helped her put on the tour of the Rumsey Block yesterday and all who helped with the planning for the meeting facilities and meals for the meeting here in Big Valley.

**Finance**. Secretary/Treasurer Barry Adams was unable to attend today but provided Maynard with a brief summary of our active accounts: As of May, 2006 there is \$1790 on deposit in Canadian funds and \$1669.79 on deposit in US Funds. Recent expenses include a \$100 contribution to the Montana Youth Range Camp and a \$125 contribution to the Montana Youth Range Days. A question was raised about the amount still set aside in the 'speakers reserve account' but Barry did not provide that detail.

**Awards**. Lou Hagner handed out two papers for consideration and discussion. The first paper sets out the goals of the awards program and lays out the purpose and criteria for the two awards the IMS has given out. After some discussion, Lou said he would make some changes in this paper and would have it ready for final discussion at the fall 2006 meeting. The other handout describes how the IMS Awards Committee is structured and the procedures they follow. **Lou stressed the need to get any award nominations into the committee by September 1, 2006.** Contact Lou for Montana nominees and Art Bailey for Alberta nominees.

**Youth Activities**. Bret Olson summarized recent activities and thanked the membership for their support of the Youth Range Camp and Youth Range Days in Montana. Bret also provided an update on the SRM's High School Youth Forum. Katlyn Keogh attended last year and IMS gave her \$400 to help defray her costs of attendance. After some discussion about the Youth Forum, Bret Olson moved and Art Bailey seconded a motion to offer two \$400 'scholarships' for next year's HS Youth Forum, one to be awarded to an Alberta student the other to a Montana student. The motion passed on a unanimous voice vote.

**Nominations for Officers and Directors**. Sue De Bruijn was nominated by Art Bailey for Director, Alberta. Barry Irving said he would contact Mike Alexander of Alberta to see if he would run for the same office. Heide Olbert and Jake Powell were nominated for Director from Montana. Other nominations are needed by September 1, 2006 so the ballot can be printed in the fall newsletter.

**Fall 2006 Meeting.** The meeting is set for Great Falls on November 3<sup>rd</sup> and 4<sup>th</sup>. If you have ideas for a speaker or topics we should cover, contact Maynard Smith as soon as possible.

**Summer 2007 Meeting.** George Hirschenberger asked that anyone with ideas for the summer meeting contact him. One idea is to hold the meeting in the Blackfoot River watershed and look at a variety of range, wetland and timber management initiatives and projects in this area.

**Membership.** Don Nelson and others emphasized that each of us needs to be looking for and recruiting new candidates who would be good members of SRM.

**Newsletter.** Barry Irving needs text and photo contributions from anyone with news or a good topic for the newsletter. For instance, articles might include 'why fall calving works', Youth Camp reports, weather updates, reprints of articles from other publications, and updates on projects you are personally involved with. Get your ideas and articles into Barry ASAP.

Barry would also like to get the e-mail addresses for any individuals or groups that might be interested in following what the IMS is doing. For example, if we plan to have a meeting soon in a town, we should send the Newsletter to some key local contacts who can help spread the word and invite interested community members to our functions.

Art Bailey emphasized the need for us to communicate with those in the 'protection or preservation' camps and talk about the benefits from disturbance from grazing, fire, etc.

#### Mike Alexander

Originally from British Columbia, Mike was exposed to the field of Rangeland Management in the Okanagan Smilkameen where there are significant resource integration issues. He received his BSc in Agriculture from the University of British Columbia and his MSc in Rangeland Science from the University of Alberta in 1995 (Response of Aspen Forests to Burning and Grazing). ## Sue De Bruijn

I grew up in Southern Alberta, between Medicine Hat and the Cypress Hills. We both farmed and ranched. I attended the University of Alberta, where I completed both a B.Sc. in Agriculture (Crop Science) and a M.Sc. in Range and Resource Management under Dr. Edward Bork. In my fourth year of undergraduate studies, I was a member of the U of A Range Team, where we competed in Hawaii, and the team won both First in Plant I.D and the URME, and personally I was 5th in Plant I.D, and Second Overall. The following year I presented a Graduate paper and poster at the Annual Meeting in Kansas City on the research I was doing for my graduate thesis, which investigated if grazing could control Canada thistle (if cattle grazing could remove Canada thistle from pasture). I have also presented this research on one of the summer tours (2001). I have worked for Alberta Agriculture at the Ag-Info Centre, for the Alberta Environmentally Sustainable Agriculture (AESA) Program, and currently work for Sustainable Resource Development (AB Government) as a Rangeland Agrologist for the Grazing Reserve Program (Southwest Region). My current job primarily consists of coordinating oil and gas activity on public land (grazing, recreation, etc.). I live at Crestomere, Alberta, where my husband and I custom graze stockers and cow/calf pairs in an intensive, rotational grazing system. We have also at times raised pastured poultry and sheep.

I am a Natural Resource Specialist for Frontier Natural Resource Consulting, basing out of Bozeman. My current work is project leader for the Blackfeet Reservation rangeland inventory. I have also provided technical assistant to ranches in Montana, Colorado, and Nebraska on livestock grazing and wildlife. I grew up in a ranching family in southwest Nebraska. My work experience before coming to Montana includes doing day work on ranches and farms in Nebraska, Colorado, Wyoming, Arizona, and California. I've lived in Montana for 7 years. During my time in Montana, I've done seasonal work for the BLM and USFS, range work for Montana State University extension service, ranch day work, and naturalist guiding. I received a B.S. in Range Science at Montana State University. I enjoy hiking, fishing, hunting, and exploring regional history.

If elected I plan on working with the section to keep developing it as a resource for current rangeland issues in Montana and Alberta.

Mark your calendars for the 2007 Summer Tour in the Lubrecht Forest (July 12, 13, 14), located about 45 minutes east of Missoula, Montana. For a virtual tour of the area and meeting facilities visit "http://www.forestry.umt.edu" and type "Lubrecht" in the search box.

The tour will give an overview of the cooperative conservation efforts that have been undertaken in the Blackfoot watershed and then make field stops that illustrate some of these efforts: The Bandy Ranch -a cooperative research facility of Montana State U and the U of Montana (the Bobcats and Grizzlies inside one pasture!) and the Blackfoot Clearwater Game Range are adjoining operations that have some interesting projects going. Another possible stop is trial pastures where goats and sheep have/are being integrated with herbicides, biological controls and revegetation to help reduce spotted knapweed and other noxious weed infestations. There are numerous places to see lands that are under conservation easements where ranching and other active management is alive and well. Habitat improvement projects for waterfowl and fish are also numerous and there are several completed fuels management projects in the area.

On the purely recreational side, the Blackfoot River offers some great Class 1, 2 and 3 boating opportunities as well as fishing. Hiking and some lake fishing are also close-by.


# Memoirs of the 2006 Summer Tour, Big Valley, Alberta



Aspen Parkland is a transition zone from grassland to forest. Grasslands dominate on south facing slopes while forest occurs on north facing slopes. As one moves further north the proportion of grassland decreases and the proportion of forest increases. Only 5-10% of the Aspen Parkland has not been cultivated. The Rumsey Block is a large remnant of Aspen Parkland that is managed by Alberta Sustainable Resource Development.
